

Cookies Policy

1. Overview

Cookies are small text files stored on your device when you visit a website. These files enable websites to remember your actions and preferences (such as login details, language selection, or other settings) over a period of time. Cookies do not carry viruses or malware and cannot access any data on your computer or alter its functions. Instead, they act as logs that store information about your interaction with a website and are updated upon each visit.

When you interact with our website(s), cookies may be sent to your browser, allowing us to access certain information about your activity. 2. Purpose of using Cookies

We use cookies for the following purposes:
